REMINDERS FOR 2024

- **Inform your provider of coverage changes** Be sure to inform your providers of changes in your benefits. This is especially important if you changed plans for the 2024 plan year.
- Medical plan ID cards If you changed medical plans during the 2024 Annual Enrollment period (e.g., moved from one of the previous Blue Shield, Health Net or United HealthCare plans to either a Kaiser or Aetna plan), you should have received your new ID card in December at your home mailing address. If you haven't received your card, or the information listed on your new card is not correct, contact your health plan directly. Contact information for the health plans can be found at *eixbenefits.com* at Health > Health & Welfare > More > Contacts & Helpful Info.

Note: If you need urgent medical care and have not received your new card, call the EIX Benefits Connection at (866) 693-4947 to speak to a representative. You'll be asked to provide your Passcode as identification, so be sure to have it on hand when you call.

- Prescription drug ID cards If you enrolled in an Edison medical plan for the first time during the 2024 Annual Enrollment period and selected an Aetna plan, you should have received a prescription drug ID card from Express Scripts. If you have not yet received your new prescription drug ID card, call Express Scripts:
 - For Non-Medicare Retirees: (877) 620-6730
 - For Medicare Retirees: (800) 978-6230

If you were enrolled in a Blue Shield, Health Net, or United HealthCare plan in 2023 and are enrolled into a new Aetna plan for 2024, your prescription drug ID card remains the same. You will not receive a new card for 2024.

If you enrolled in a Kaiser plan for 2024, you will not receive a separate prescription ID card.

WHAT IS A QUALIFIED LIFE EVENT?

During Annual Enrollment, you have an opportunity to make changes to your benefit elections for the next plan year. Usually this is your only opportunity to make changes to your elections, but what if your benefit needs change outside of Annual Enrollment?

You can make changes to your benefit elections outside of the Annual Enrollment period if you experience a *qualified life event*. A qualified life event is when you experience a change in your life or financial situation in which you lose or need to change your benefits coverage, such as getting married, birth or adoption of a child, retirement, becoming disabled, or a loss of health coverage.

- If you experience a qualifying life event other than birth or adoption of a child, you can make changes to your benefit elections within 30 days from the date of the event.
- If you experience the birth or adoption of a child, you have 60 days to report the event and make changes to your benefit elections. *Please note:* If you are adding a newborn to your coverage, you do not need to wait until you receive a Social Security number (SSN) for your dependent. You may report the event within the 60-day window and provide an SSN prior to the child turning age one.

In most cases, your new coverage takes effect on the date of your qualified life event. Generally, if you do not report your qualified life event within these timeframes, you will not be able to make changes to your elections and must wait until the next Annual Enrollment to do so.

Reporting a Qualifying Life Event

- **Online:** Visit *eixbenefits.com* and click on the tab Work/Life Events. In the section *Explore or Report a New Life Event*, click on a life event. Follow the prompts to enter the date of your event.
- **By phone:** Call *EIX Benefits Connection* at (866) 693-4947 and speak to a representative to report your life event. Representatives are available Monday through Friday, 7:30 a.m. to 5:30 p.m., Pacific time, except holidays.

Important

Whenever you add a dependent to your health coverage, you will be required to provide documentation that verifies your relationship. NEW EMPLOYEE ENGAGEMENT VENDOR COMING IN MARCH

As we mentioned last fall, **America's Charities** will become our new employee engagement vendor. This change and the launch of a new platform will occur by the end of March.

In the meantime, we still want to encourage you to support our communities.

Give Time: Volunteer in your communities and keep track of your hours. Once the new platform is up and running, you can log your hours and earn a \$100 incentive for every 40 hours volunteered. You can use this incentive towards an eligible organization of your choice, and you can earn up to \$600 a year.

DIRECT BILLING REMINDERS

If you are enrolled in retiree health care and have elected direct billing, here are a few things to keep in mind:

- **Billing:** Bills are generated on approximately the eighth of each month for the next month's coverage.
- **Due date for payment:** Payment for coverage is due the first of the month.
- **Pre-paying for coverage:** You can pre-pay your health care premiums through the end of the plan year. To determine your prepayment amount, simply multiply your monthly premium by the remaining months of coverage for the plan year. In your monthly invoice, the prepayment amount will be reflected as a credit against your current monthly premium.
- Switching to direct debit: You can choose to make your monthly payments electronically through direct debit from any U.S. checking, savings or money market account. You can sign up for direct debit online or by calling the *EIX Benefits Connection* at (866) 693-4947 to have a Direct Debit Authorization Form mailed to you. Your direct debit cannot take effect unless your account is current.

Note: Keep in mind that in all cases, failure to make timely payments for your portion of the coverage will result in that coverage being canceled. If this occurs, you may be permitted to enroll in medical coverage as the result of a qualified life event or at Annual Enrollment. However, you will not be eligible to enroll in dental or vision coverage in the future.

California must evaluate options quickly, including greater use of emerging technologies such as carbon capture, to find the most feasible and affordable solutions to achieve net zero. What happens in California can be a model for other states and nations, and Edison is committed to helping the state reach its goals.



REMINDER ABOUT INCOME-RELATED MEDICARE ADJUSTMENT AMOUNT (IRMAA) REIMBURSEMENTS

The Social Security Administration charges a Medicare Part D (prescription drug) and Medicare Part B (medical) IRMAA to those with annual earnings above a certain limit. If you are enrolled in one of Edison's Medicare Advantage or Medicare-coordinated plans and are required to pay a higher Part D IRMAA premium, you can apply to the company for reimbursement.*

To determine if an IRMAA is being deducted from your Social Security benefit payment, review your most recent Social Security statement. If it shows that there has been an IRMAA deduction, you may be eligible for a reimbursement.

Requests for reimbursement can only be made for the current and previous year's coverage. For example, only IRMAA reimbursement claims submitted for 2023 and 2024 will be reimbursed during the 2024 plan year. Any request for reimbursement of coverage prior to the 2023 plan year will not be processed. If you are eligible, you must submit your reimbursement request by Dec. 31, 2024.

For 2024 Medicare Part B and/or Medicare Part D IRMAA reimbursements, you must submit a request to the EIX Benefits Connection in one of the following ways:

* If you retired prior to Jan. 1, 1993, you may also be eligible for a full or partial reimbursement of your Part B IRMAA.

If You Newly Enrolled in a new Aetna Plan:

You should have received medical insurance cards for you and your enrolled dependents in December. If you haven't received new cards, please contact Aetna Member Services.

- If enrolled in the HMO MAP or PPO MAP: (866) 409-1265

If you need a temporary ID card, visit *aetna.com* and log in or register. On the top right-hand side of the home page, click on the dropdown arrow to the right of your name. Choose ID Cards. Click on the printer icon to print a copy, or the share icon to send your card to an email address.

Shine a Light on SUBSTANCE USE

Is Substance Dependency Impacting Your Life?

Statistics suggest that substance use impacts a staggering number of people each year.

- Over the last twenty years more than one million people have died from drug overdoses.
- In 2021 alone, there were over **106,000** overdose deaths in the U.S.
- The Department of Transportation (DOT) has reported that nearly 37 people die daily from drunk-driving crashes.
- From 2020-2023, employers reported nearly 200,000
 DOT drug and alcohol testing program violations in the Federal Motor Carrier Safety Administration (FMCSA)
 Clearinghouse.

Substance use disorder is a chronic disease that is complex and not easy to overcome because substance use alters the brain in ways that make it difficult to stop. Someone coping with addiction may be unable to control their compulsion to use a substance despite being aware of the negative impacts it may have on their health, relationships, careers, finances, etc. If they can gain control and overcome their addiction, the battle does not stop there, but may go on for years or even decades. Relapse is common.
